5. <u>SECRETARY'S REPORT</u>

Mr. Baroody gave the following update:

- Research and Tech Park Update Silver Companies has given the Stafford Board of Supervisors 2 acres and will pay for already established 1140sf of leased space for classes to be offered by George Mason University, University of Mary Washington, and Germanna Community College. Discussion followed.
- Economic Development Website –The new Economic Development website has launched with the address, <u>www.GoStaffordVa.com</u>. The new website focuses on site selectors needs.
- Stafford County's Annual Business Appreciation Luncheon Bethany Miller spoke. The luncheon will be held June 7, 2012 at Riverside Conference Center. This year's theme is "The Year of the Entrepreneur" and the EDA will be giving two awards for "Entrepreneur of the Year". The Key note speaker will be Martin Briley, President and CEO of Virginia Economic Development Partnership.
- Leadership Fredericksburg 2012 Future sponsorship may be asked for but not at this time. Graduation will be May 18th, 2012. Brenda Schulte who the EDA sponsored will be graduating; she is the county's Ombudsman.
- Virginia Industrial Development Authorities Institute The VIDA is hosting a 2-day seminar on developing positive business environments on May 22nd and 23rd.
 Stafford's EDA is welcome to attend.

7. COMMITTEE REPORT

- On April 17, 2012 Mr. Rowley and Mr. Rowley attended the Leadership and Philanthropy Luncheon representing the EDA recognizing the contributions the EDA made to Germanna Community College.
- HH Hunt has sent a contract to Mrs. Smith for her 25 acres. HH Hunt will purchase the land for \$1MM; the land will be used for a Germanna Community College site.
- In March the EDA was sent a PowerPoint CD presentation on the partnership between Virginia Beach Government and Virginia Beach Public Schools and the community college for a technical center. A copy was sent to Mr. Newlin and Mr. Griffin.

8. OLD BUSINESS

- Fredericksburg Regional Alliance (FRA) Mr. Gene Bailey gave a presentation to the Economic Development Authority on the Fredericksburg Regional Alliance's new Strategic Plan. On May 23, 2012 the FRA with have a special Board Meeting and July 9th will be a FRA Regular Board Meeting; both these meetings will focus on finding a plan to put in place. The EDA would like to appoint one member to work with other area EDA members in assisting the FRA with the creation of their Strategic Pan. FRA metrics were requested for next meeting. Discussion followed.
- Virginians for High Speed Rail The VHSR briefed the EDA in March on their group's activities and asked the EDA for a donation. The EDA discussed the request and decided not to contribute at this time.

9. NEW BUSINESS

- Airport Terminal Building Stafford Regional Airport sent a letter to the EDA consisting of the site plan of the proposed new terminal and runway enlargement. As an adjacent land owner the EDA may offer comments to the planning office, if desired. Stafford Regional Airport has approached the Board of Supervisors to support a \$1.3MM loan; no decision has been made by the Board at this time. More discussion planned for July's EDA meeting. Discussion Followed.
- EDA Airport Property Inquiry EDA received a request for timbering of the EDA's airport property. The EDA agrees to sell the timber.
- EDA Logo An EDA logo was chosen

•	Workforce Investment Board (WIB) - Mr. Rowley has represented the county on
	the WIB for the last 2 ½ years and has chosen not to continue. He would like
	someone from the EDA to replacement him. A formal nomination by the Stafford
	Board of Supervisors will be required once the EDA has chosen Mr. Rowley's
	replacement.
