- Economic Development Website –The new Economic Development website has launched with the address, <u>www.GoStaffordVa.com</u>. Feedback from the EDA and public is welcome.
- Stafford County's Annual Business Appreciation Luncheon Bethany Miller spoke. The luncheon was held June 7, 2012 at Riverside Conference Center. This year's theme is "The Year of the Entrepreneur" and the EDA gave two awards for "Entrepreneur of the Year". They went to Web Business Solutions Inc. and Potomac Point Winery. - HH Hunt has sent a contract to Mrs. Smith for her 25 acres. HH Hunt will purchase the land for \$1MM; the land will be used for a Germanna Community College site. Mrs. Smith is reviewing the contract with her attorney. She is anticipating signing the contract mid-July. HH Hunt will sing directly following Mrs. Smith.
- DR Horton (Cliff Farms) 500 Acres, they would like to proffer 230 acres to the county for 50 soccer fields. DR Horton, if the county desires, will set aside 50 acres of the 230 for a Germanna Community Site. DR Horton has agreed to build the first 15 soccer fields and the country would be responsible for the rest.
