A. CEDC Update

Ms. Knight presented highlights from the most recent CEDC meeting. The CEDC discussed the option of permitting Apiaries in R-1 zoning. The A-1 zoning minimum lot size was discussed to be reduced to 5 acres as part of the Healthy Growth Initiative. The temporary light at Telegraph and US Rt1 will become permanent.

The CEDC also discussed the Patawomeck Tribes lease at Duff Green park. There will be public hearing within the next few months.

Discussions regarding the Historic Port of Falmouth parking lot and beach cleanup remain controversial and in question.

A. ED&T Update

Staff continues to work on the EDA's grant and incentive program/policy for the targeted areas. Mr. Holden would also like to propose the County establish a Tourism Zone to allow the EDA participate in the Virginia Tourism Development

Financing Program. He is also re-exploring the use of the C-PACE program.

Mr. Holden and staff will be finalizing an extending business attraction calendar in the coming months. They will be attending SelectUSA in June, to meet with interested foreign businesses looking to expand in the US. Staff is also offering a partnership with FRA to organize "Fam Trips" for a small number of site consultants, as well as regional collaborations using Regional Industries Facility Act "RIFA" to develop and market properties in the FRA region.
