#### 3. PUBLIC PRESENTATIONS

Dr. Towery and Ms. Wicker gave a presentation of the Cyber 4+ grant program and noted the following:

- Program is a partnership with Germanna Community College, GCubed, Inc., and Stafford County Economic Development & Tourism. Funded by a two-year grant (now entering year two).
- Program offers students credits for both high school and 1 year of college upon completion without debt.
- First cohort of students has been recruited.
- Program will produce well-educated and prepared students to address the current workforce talent need in cyber technology.
- Additional 'outside' help will be needed to: adjust students to cyber security class workload, mentor students, and finding internship possibilities for them.
- Cyber 4+ Roundtable meeting will be held on August 23, from 8:30-9:30am in the Testbed for any interested in mentoring students and offering suggestions on how to replicate Cyber 4+ in other industries that have critical shortages.

EDA Member questions:

- Mr. Griffin asked if the Cyber 4+ program will address the cyber security workforce need and Dr. Towery stated that she believes that this program will play an important role to fill that need.
- Mr. Owen inquired what happens after the initial grant funds are depleted? Dr. Towery is hopeful that outside fundraising and additional grants will allow the program to continue, but noted a multi-tiered approach will be needed to achieve ongoing program success. Mr. Owen asked how much money is needed for this program? Ms. Wicker stated that direct cost will be about \$164,000 for a cohort of 20 students for the 4 years. Mr. Owen inquired if students will contribute to these costs and Ms. Wicker indicated some parents may be able to offset some program costs, but not all can and that the school system is currently seeking solutions for this. Mr. Owen asked if the program is open to all students? Dr. Towery noted it is open to the five current high schools currently though some programs will shift when the sixth high school is built.
- Mr. Wilson inquired what level of certification will the students be receiving? Ms. Wicker stated the credentials issued will be the same as if students started the program in college and noted that they will be ready to be employed once graduated from the program.
- Mr. Griffin added the following:

Five years of actual work experience has been needed prior to this program and that the students will be very marketable as soon as they graduate. Stafford schools already do not have enough teachers and those who are employed with Stafford schools are often recruited by larger schools and companies.

Mr. Griffin noted that the jobs the students will be getting after graduation from the



Cyber 4+ program pay double what teachers receive and due to this it is difficult to retain and recruit teachers. We need to engage professionals in the cyber security field to come into schools and help with this program.

- Mr. Holden noted that Cyber 4+ will be looking to involve local companies for funding.
- Supervisor Allen asked if we can utilize UMW professors for this program to help cut cost? Mr. Griffin stated it is hard to get companies to invest in only a year-long program and suggested a meeting with the Chamber of Commerce may present some funding options.

Mr. Griffin asked if Supervisor Allen had any more comments to add and thanked her for her interest and attendance. Supervisor Allen stated she was present on her own and did not represent the Board of Supervisors. She added she would encourage the EDA to consider the following project:

A "Food Truck Friday" that might utilize the Moncure School lot. This location would offer visibility and it is owned by the County. She thinks that doing something in this area will instill Route 610 with a new vibe and hopefully attract new restaurants in the area in future; Perhaps this project idea would be something the EDA could sponsor.

Mr. Griffin stated the EDA wants to collaborate more with the BOS and noted that a monthly newsletter summarizing what the EDA is accomplishing will be emailed soon.

#### 4. TREASURER'S REPORT

A. Current Financials

Mr. Owen stated the year ended with \$2.6 million in assets, thanked Mr. Summits for the detailed July loan progress report, and noted that due to no budget red flags and this month's long agenda, he will discuss the Treasurer's Report and Budget in detail next month. Mr. Holden stated that ED&T is currently collecting information for the FY22 audit.

#### 5. OLD BUSINESS

Mr. Griffin noted that at the July 5 joint BOS and EDA Meeting and recognized that both groups were not satisfied with the outcome and opened the floor for comments

- Mr. Rowley stated that the BOS was very clear that they would like EDA to focus on bringing more sit-down restaurants to Stafford County. Mr. Rowley suggested a vacant restaurant on Route 17 that closed in 2019 and could possibly be used. Mr. Rowley would like to see an outline of a plan the EDA can use to address this subject of new restaurants.
- Ms. Hagerman noted that attracting restaurants is not easy and will take a significant effort.
- Mr. Owen suggested hiring a consultant to explore what Stafford has to offer restaurants as ED&T is limited in staff.
- Mr. Newlin stated that running a restaurant is very difficult. He added that restaurants will come where business is. In his experience, 70% of restaurants will



fail. The EDA's mission for Stafford County is to attract economic development and that in his opinion there are more important efforts and that ED&T staff should not be focusing on restaurants only.

- Supervisor Allen remarked that there is a disconnect between the BOS and EDA and indicated that a consultant may be a good idea, the consultant's documentation will help the BOS know why restaurants aren't coming to Stafford County and would open dialogue on how to best develop locations for restaurants.
- Mr. Griffin stated that the BOS has given EDA a large challenge. He is concerned that the Board does not understand how business works or the requirements needed to bring restaurants to Stafford. Mr. Griffin noted that EDA and ED&T can spend a lot of time and money into bringing restaurants to the County, but the Board should consider the need for approving more densely populated neighborhoods, considering how to do so with appropriate proffers, zoning, and other tools at its disposal.
- Mr. Cummings remarked that the BOS seems frustrated with the lack of data and asked how EDA can bring about the change that the Board's constituents desire. Mr. Griffin reiterated that there are a number of issues and problems that the EDA encounters when trying to bring restaurants and businesses to this area and suggested the BOS and County could help with these issues—that perhaps input from the Planning Commission encouraging economic development may help. Mr. Griffin added that the EDA? With EDA guidance and support has generated millions of dollars for the County and requested that the BOS not lose sight of this.
- Mr. Holden noted that since the joint BOS and EDA meeting the Department has considered how to proceed with a "Retail Action Plan" and handed out a draft of that plan. After briefly reviewing and noting that it is still being refined, he asked for input:
  - Mr. Owen remarked that the BOS takes too long to approve a project and Supervisor Allen replied that the BOS often does not know the urgency.
  - Mr. Griffin stated that the EDA believes all BOS members want more economic development but also senses a lack of trust in the EDA. The EDA meets monthly and advises the ED&T Department. The EDA does not have several months' time to wait on BOS decisions. There are many examples of this and noted that when the EDA (through the Department) brings a project to the BOS, the EDA has already vetted the project to a large degree.
  - Supervisor Allen urged all EDA members to contact their respective Supervisors so they will become more aware of projects and issues and won't have so many questions that may hold things up. Supervisor Allen noted that if supervisors don't understand something, they will not approve it and suggested EDA members creatively find ways to keep the BOS informed. Mr. Owen stated some EDA members have contacted their Supervisors for months, but to no avail. Supervisor Allen advised EDA to be sure Supervisors know the specifics of projects.
  - Mr. Cummings requested talking points from the EDA so he can take them before the Planning Commission and stated that communication is key.
  - Mr. Rowley remarked that the Mason-Dixon Café was not listed on the Retail Development Action plan and suggested their business plan model may be a good one to replicate due to their success.
  - Mr. Payne stated there are unique opportunities for Stafford County and



stressed a comprehensive plan that includes investments. He advised that Stafford County needs a central place like Falmouth or Fredericksburg and suggested approving projects that bring synergy.

• Mr. Griffin stated EDA can provide data, but businesses need a business reason to come to Stafford and stay in Stafford County.

#### 7. SECRETARY'S REPORT

- A. Go VA Grant Update
  - Mr. Holden noted the following:
    - RIoT Pitch Night will be held on August 24, at the Fredericksburg Area Museum Market Square from 5:30-8:30 p.m. and urged members to attend.
    - Three members of the RIoT Cohort are currently working on Testbed projects
    - One of these Cohort members is seriously talking of starting a business in Stafford County, with their start-up location being the Testbed.
    - RIoT's next Accelerator program series will be held October 5-December 22; applications due on September 1.
    - Mr. Holden recommend that the EDA sponsor of the RIoT Pitch Night by offering a prize for the pitch contest winner. Mr. Owen asked what sponsorship cost is usually. Mr. Holden replied that \$2,500 is typical and noted that some companies will turn down a Pitch invite if there is no award given. Mr. Owen stated that he would be in favor of a \$5,000 sponsorship.

Mr. Griffin motioned to approve this \$5000 sponsorship for the Pitch winner. Ms. Hagerman seconded.

- B. VEDP Business Site Ready Funds next business park
  - The EDA has been invited to submit full application for two sites in South Stafford.
  - Currently working on this application and will submit it by September 13.
  - More information will be given at EDA September 9 meeting.
  - EDA will be the applicant.
- C. American Junior Golf Association Allstar Tournament Update
  - Starts Sunday, August 14, with the EDA-sponsored Pro Am.
  - There are twelve teams and an estimated \$10,000 to go to charity.
  - 70-80 golfers will play and these golfers come with families that stay and eat in local hotels and restaurants.
- D. Marketing & Events Update
  - The August 12 Wine & Business was a great success with 62 attendees.
  - Next Beer & Business is November 9.

A. Loan Committee (*H Owen, D Davis, J Summits*)

- Newest loan to Embrey Mill Primary & Urgent Care is for \$108,000 at 4.25 percent.
- Total loans to date: \$218,000 and loans are current
- Mr. Summits is reviewing and underwriting another Business Growth Fund application (location is off Route 1 near Weiss Market) and this may be ready for vote next month.
- Another similar Business Growth Fund application for a shooting range is also in the works.
- One of these loans will assist with building acquisition (expanding an existing business) and the second with debt financing. Mr. Rowley asked how much they are asking for and Mr. Summits replied he is still working with the applicants and reminded the EDA that the loan program allows up to \$200,000 for each loan.
- Mr. Rowley suggested the C-PACE program could be of use with business loans.
- Mr. Holden noted that EDA loans were featured in ED&T's last newsletter. Mr. Summits stated he received six loan inquiries in one day due to this marketing works. Ms. Browne mentioned that EDA loans will again be the feature for the next newsletter.
- Mr. Summits stated that current loans are generating about \$500 of interest revenue each month.

- A. Consideration of a Startup Tech Incentive Grant\Loan Per Supervisor Allen request, staff has drafted a Startup Tech Grant\Loan program for consideration. Mr. Holden noted the following requirements for the grant\loan:
  - Company must be located in Stafford County



- Relatively small business
- Tech-oriented
- Have completed the RIoT Accelerator program (or similar program)
- Testbed Executive Committee would look over the company's technology, making sure it is valid.
- \$25,000 forgivable loan incentive (\$100,000 a year; 4 loans awarded)
- He suggested that the EDA may approach the BOS to ask it it may be willing to support this with their Opportunity Fund which is set up each year with budget of \$500,000. The payment of future taxes could replenish the Fund.

Mr. Summits remarked that this is an inventive way to bring a new type of capital and new business to Stafford County. Mr. Rowley stated that the program is interesting, but feels that \$25,000 is almost nothing to a business trying to get established. Mr. Hendon replied that the \$25,000 is just an initial investment to help businesses raise capital and that EDA succeeds most when the loans are forgiven. Mr. Griffin asked if this Startup Loan program would need member approval in order for the Treasurer to move money. Mr. Summits stated that this would depend on the source of the funds (Opportunity fund, fundraising grants, sponsorships) that program will use. Mr. Holden stated that EDA's loan policy may have to be adjusted for this program and that any money from the BOS fund would require the Board's approval. Supervisor Allen remarked that the BOS may be interested in a 'bet on us, we'll bet on you' type of program.

  - Supervisor Allen urged all EDA members to contact their respective Supervisors so they will become more aware of projects and issues and won't have so many questions that may hold things up. Supervisor Allen noted that if supervisors don't understand something, they will not approve it and suggested EDA members creatively find ways to keep the BOS informed. Mr. Owen stated some EDA members have contacted their Supervisors for months, but to no avail. Supervisor Allen advised EDA to be sure Supervisors know the specifics of projects.
  - Mr. Cummings requested talking points from the EDA so he can take them before the Planning Commission and stated that communication is key.
  - Mr. Rowley remarked that the Mason-Dixon Café was not listed on the Retail Development Action plan and suggested their business plan model may be a good one to replicate due to their success.
  - Mr. Payne stated there are unique opportunities for Stafford County and



stressed a comprehensive plan that includes investments. He advised that Stafford County needs a central place like Falmouth or Fredericksburg and suggested approving projects that bring synergy.

• Mr. Griffin stated EDA can provide data, but businesses need a business reason to come to Stafford and stay in Stafford County.

#### 7. SECRETARY'S REPORT

- A. Go VA Grant Update
  - Mr. Holden noted the following:
    - RIoT Pitch Night will be held on August 24, at the Fredericksburg Area Museum Market Square from 5:30-8:30 p.m. and urged members to attend.
    - Three members of the RIoT Cohort are currently working on Testbed projects
    - One of these Cohort members is seriously talking of starting a business in Stafford County, with their start-up location being the Testbed.
    - RIoT's next Accelerator program series will be held October 5-December 22; applications due on September 1.
    - Mr. Holden recommend that the EDA sponsor of the RIoT Pitch Nigh by offering a prize the pitch contest winner. Mr. Owen asked what sponsorship cost is usually. Mr. Holden replied that \$2,500 is typical and noted that some companies will turn down a Pitch invite if there is no award given. Mr. Owen stated that he would be in favor of a \$5,000 sponsorship.

Mr. Griffin motioned to approve this \$5000 sponsorship for the Pitch winner. Ms. Hagerman seconded.

- B. VEDP Business Site Ready Funds next business park
  - The EDA has been invited to submit full application for two sites in South Stafford.
  - Currently working on this application and will submit it by September 13.
  - More information will be given at EDA September 9 meeting.
  - EDA will be the applicant.
- C. American Junior Golf Association Allstar Tournament Update
  - Starts Sunday, August 14, with the EDA-sponsored Pro Am.
  - There are twelve teams and an estimated \$10,000 to go to charity.
  - 70-80 golfers will play and these golfers come with families that stay and eat in local hotels and restaurants.
- D. Marketing & Events Update
  - The August 12 Wine & Business was a great success with 62 attendees.
  - Next Beer & Business is November 9.
  - Veteran's Boot Camp will be held October 25, from 8:30am-2pm at UMW's Stafford Campus.



- The Department and EDA are working to further improve and enhance the Stafford Airport marketing efforts. The Airport marketing goals are to attract corporate businesses and general brand awareness support.
- The Airport, working with ED&T and the Smart Community Testbed is exploring the development of sites for unmanned aircraft (drone) technology.

#### 8. COMMITTEE AND WORKING GROUP REPORTS

A. Loan Committee (*H Owen, D Davis, J Summits*)

- Newest loan to Embrey Mill Primary & Urgent Care is for \$108,000 at 4.25 percent.
- Total loans to date: \$218,000 and loans are current
- Mr. Summits is reviewing and underwriting another Business Growth Fund application (location is off Route 1 near Weiss Market) and this may be ready for vote next month.
- Another similar Business Growth Fund application for a shooting range is also in the works.
- One of these loans will assist with building acquisition (expanding an existing business) and the second with debt financing. Mr. Rowley asked how much they are asking for and Mr. Summits replied he is still working with the applicants and reminded the EDA that the loan program allows up to \$200,000 for each loan.
- Mr. Rowley suggested the C-PACE program could be of use with business loans.
- Mr. Holden noted that EDA loans were featured in ED&T's last newsletter. Mr. Summits stated he received six loan inquiries in one day due to this marketing works. Ms. Browne mentioned that EDA loans will again be the feature for the next newsletter.
- Mr. Summits stated that current loans are generating about \$500 of interest revenue each month.
- B. Germanna Group (*J Rowley*) Items for Closed Session only
- C. Property Group (D Hendon, H Hagerman, J Rowley) Items for Closed Session only
- D. Broadband Expansion (*D Hendon, M Wilson*)

Mr. Holden noted that the County is applying for a Virginia Advanced Technology Infrastructure Grant that would allow for the significant increase of broadband reach in the eastern area of the County.

#### 9. <u>NEW BUSINESS</u>

- A. Consideration of a Startup Tech Incentive Grant\Loan Per Supervisor Allen request, staff has drafted a Startup Tech Grant\Loan program for consideration. Mr. Holden noted the following requirements for the grant\loan:
  - Company must be located in Stafford County



- Relatively small business
- Tech-oriented
- Have completed the RIoT Accelerator program (or similar program)
- Testbed Executive Committee would look over the company's technology, making sure it is valid.
- \$25,000 forgivable loan incentive (\$100,000 a year; 4 loans awarded)
- He suggested that the EDA may approach the BOS to ask it it may be willing to support this with their Opportunity Fund which is set up each year with budget of \$500,000. The payment of future taxes could replenish the Fund.

Mr. Summits remarked that this is an inventive way to bring a new type of capital and new business to Stafford County. Mr. Rowley stated that the program is interesting, but feels that \$25,000 is almost nothing to a business trying to get established. Mr. Hendon replied that the \$25,000 is just an initial investment to help businesses raise capital and that EDA succeeds most when the loans are forgiven. Mr. Griffin asked if this Startup Loan program would need member approval in order for the Treasurer to move money. Mr. Summits stated that this would depend on the source of the funds (Opportunity fund, fundraising grants, sponsorships) that program will use. Mr. Holden stated that EDA's loan policy may have to be adjusted for this program and that any money from the BOS fund would require the Board's approval. Supervisor Allen remarked that the BOS may be interested in a 'bet on us, we'll bet on you' type of program.

#### 10. EXECUTIVE SESSION

The EDA Board went into closed session in accordance with Section 2.2- 3711.A.3 and 5, et al. of the Code of Virginia 1950, as amended. No Votes were taken while in closed session. Members of the EDA present at the meeting were in the closed session.

#### Greetings Stafford County Economic Development Authority Members,

On behalf of the RIoT organization, I would like to thank you for your continued support of our efforts in the region.

July concluded RIoT's first RIoT Accelerator Program (RAP) cohort in Virginia. We had seven companies participate in the program: one was from Canada, three from out of Virginia, and three from Virginia, with two from the Stafford region.

In August, we hosted our first Pitch Night in Virginia. The companies in the RAP cohort pitched their companies to a panel of judges. The judges included Debi Roder, Director of Entrepreneurial Ecosystems, Virginia Innovation Partnership Corporation (VIPC), Vernon Green, President and CEO, GCubed Inc., Beckey Gallamore, President/Owner, Rocky Top Embroidery & More Inc and Chairperson, King George County Economic Development Authority, Curry Roberts, President, Fredericksburg Regional Alliance, and Billy Beale, CEO, Atholwood Consulting Services and Chair, GO Virginia Region 6.

August's event was sponsored by the Virginia Smart Community Testbed, the City of Fredericksburg, the King George Economic Development Authority, and PPB Law.

The winner of the pitch event was awarded \$5,000, courtesy of the Stafford County Economic Development Authority.

Latticet, a company that seeks to prototype a material piece that provides power and transmits communication signals more efficiently at a material microscopic level, won the pitch competition. At the event, the founder indicated she would use the money provided to purchase materials to begin product development of her computer simulations.

RIoT maintains relationships with each of these companies and will continue to track and monitor their progress as they grow.

The same week as pitch night, RIoT hosted a week long Business Foundations program in conjunction with the Bay Consortium Workforce Development Board that serves Stafford to the Eastern Shore. RIot staff met with 9 idea stage entrepreneurs, hosted 5 workshops, and conducted daily individual 1:1s with each participant.

Looking ahead, RIoT will be moderating a panel with Stafford EDT and VIPC at the Smart Cities Connect conference in DC to highlight the partnerships involved in the Virginia Smart Community Testbed. We look forward to to discussing the work happening here on this world stage.

We look forward to kicking off on next cohort of the RIoT Accelerator Program and hope that each of you will join us for lunch to meet our startups on October 5 and consider volunteering to mentor a company.

Overview:							
At the request of the Committee, a brief presentation on the data center industry will be made by individuals representing the industry, Dominion Power, and the Fredericksburg Regional Alliance, followed by a question and answer time.							

#### **Discussion/Analysis:**

Virginia, notably Northern Virginia, is home to the largest concentration data centers in the world. Data centers are physical structures that house computing equipment for the purpose of storing and processing the massive amounts of data integral to the technology people use every day. Over the past decade, the data center industry has grown significantly in Virginia due to access to infrastructure, workforce, and a favorable business climate. The Pandemic further accelerated that growth when it created a surge in new internet traffic to support growth of cloud technology and virtual collaboration for businesses. As companies evolve, data centers will continue to expand and adapt to meet the increased need from businesses and communities for new technology, online services, and remote work capabilities.

A report by Mangum Economics in 2022 estimated that for every 1 Million SF of Data Center development in Stafford County, the County should estimate an annual fiscal influx of \$18 Million in direct tax revenue, 150 FTE jobs with 24 Million in associated pay and benefits, and 400+ jobs via indirect and induced economic activity.

According to a report by Northern Virginia Technology Council also completed by Magnum Economics,

the data center industry employed 5,550 operational jobs and 10,230 construction and manufacturing jobs generating \$1.6 billion in associated employee pay and benefits and a total of \$7.5 billion in economic output. Taking into account the economic ripple effects generated by that direct impact, the total impact on Virginia from data centers in 2021 was approximately 45,460 supported jobs, \$3.6 billion in associated employee pay and benefits and \$15.3 billion in economic output. For every job inside a Virginia data center, there are 4.1 additional jobs that are supported in the rest of the Virginia economy.

In 2020, the local benefit to cost ratios associated with the industry in Loudoun County equal for every \$1.00 in county expenditures that data centers were responsible for generating, it provided approximately \$13.20 in tax revenue. In Prince William County, for every \$1.00 in county expenditures that data centers were responsible for generating, it provided approximately \$13.50 in tax revenue.

The most widely recognized, and publicized, challenge facing data centers is their cumulative energy consumption. Dominion Power has announced its plans to expand its use of renewable energy sources to lessen their reliance on fossil fuels. As of 2021, 36% of all solar energy produced by Dominion Energy in Virginia was directly attributable to data centers. Most of the data center operators already run on 100% renewable energy (e.g., solar, wind, geothermal). Typically, data centers offset their non-renewable power use by purchasing renewable energy certificates (REC) and power purchase agreements (PPA). The REC allows the purchaser to take "credit" for the RECs as renewable power "use" and PPAs can be purchased from a qualified renewable resource without requiring its direct use.

Access to water is another important need and potential impact on county infrastructure. Data center use of water varies widely by the type of facility. The industry has developed a variety of technologies to cool facilities and recirculate water. This includes, as example, using non-potable water sources. Many data center operators use recycled water for cooling in northern Virginia.

Stafford County, working with the Fredericksburg Regional Alliance (FRA), at the wishes of the Board, began exploring and marketing data centers beginning in 2015. On behalf of Stafford, the FRA worked with Dominion to focus on vetting potential data center locations and marketing efforts on sites that were in very close proximity or with direct access to power lines to avoid the need to extend lines across other properties.

In 2019, the member communities of the FRA worked together, with the leadership of Stafford County Commissioner of Revenue, and agreed to a set a common tax rate for data centers across the Greater Fredericksburg Region. This rate (Stafford's) is currently \$1.25 and has made Stafford County and the region very appealing to the Data Center market.

Per Stafford County's current zoning code, data centers are permitted in B2 Urban Commercial Zoning District, RBC Recreational Business Campus District, M1 Light Industrial District, M2 Heavy Industrial District, and the ICTP Integrated Corporate and Technology Park Overlay. As with any other use, they are subject to Site Plan approval and must meet current ordinance requirements for parking, lighting, landscaping, setbacks, building height, etc. required by each district.








### Data Centers: A Statewide Opportunity



#### DRAFT

#### **Background**

- Please see the attached provided to the Joint BOS-EDA Meeting on July 5 (attached). As a result of that meeting, Staff have developed this Retail Development Action Plan.
- Current program has expanded retail/commercial by 100+ locations directly; many more indirectly
- Focus has been on major brands. Staff has had role in the following:
  - The first focused "win" was Chipotle' on Route 610. The first Chipotle' opened in December 2014; the second Chipotle' on US Route 17 opened in December 2015.
  - Many other stores followed in similar fashion, including Wawa, Sheetz, Royal Farms, Panda Express, 7 Eleven, and more. These stores continue to grow and expand; some developing new sites in Stafford
  - $\circ$  Staff assisted and encouraged the expansion of Mission BBQ and Umi's Japanese restaurant.
  - ED&T Staff assisted our local breweries from zoning code to expansions, as well as covid-19 grants.
  - ED&T Staff assisted in the recruitment and locating of Panda Express (now with two locations); Fatty's Taphouse; El Patron; Marco's Pizza; Royal Farms; Lidl; Starbucks; Firestone; Aspen Dental; Dunkin Donuts (now with three locations); IHOP South Stafford; Bojangles; Sonic; Freddy's; Publix
  - ED&T Staff assisted a number of medical and health companies locate (and expand) to Stafford: Anytime Fitness; Triton Fitness: Helping Hands; Fleming Therapy; KidMed; Fresenius Kidney, Virginia Oncology, Embry Mill Urgent Care (including an EDA loan).
  - Some confidential pending brands have been recommended and introduced to brokers, including brand steakhouses and other national brands for locations along Garrisonville Road and other locations.
- Approach. Our approach has been to conduct
  - Outreach to Brokers; Broker relationships; sharing opportunities
  - Outreach to owners; small businesses; restaurant groups
  - Outreach to major brands

#### Larger Local Area Context

Retail development follows "Place" development, in that the kinds and types of retail follow the development of different types of "places." Retail types around a quality shopping center next to a highway interchange are different from those in a residential-dense "downtown." Working with Planning and engaging the public in a variety of ways, we would like to explore *Stafford Area Place Development Plans*. These would be integrated into a broader county-wide and region-wide economic development strategy. *The Department will initiate planning and some brainstorming sessions internally and with the EDA during FY2022 and will seek funding for additional consultant assistance for an updated comprehensive economic development action strategy that encompasses Place development in FY2023*.

At the same time, we propose the following <u>Action Plan</u> for enhanced retail development. The following include actual plans in place and other ideas for input and discussion. Actual plans in place are in green.

#### Retail Development Acton Plan FY2023

- Focused Marketing. We will continue and expand our focused marketing and outreach to the broker and developer committee.
  - ICSC September 14-15 2022, National Harbor
  - Direct marketing around ICSC includes:
    - Reviewing attendees list of 636 to identify leads for Stafford
    - Pull lead generation list into ED&T CRM
    - Develop and send out pre-conference Stafford branded email to lead generation list
    - Staff attending will have a LinkedIn branded post to meet potential clients
    - At ICSC staff will meet with and collect business cards with leads
    - After ICSC staff will follow-up via email communications to narrowed leads
    - One month after initial email communications follow-up, staff will follow up a second time with narrowed leads list
  - Send postcards outlining the program to a list of restaurant groups in the DMV.
  - Make a video presentation of some vacant spaces that would be good restaurant locations that can be sent via email to interested users.
- Additional and documented and outreach (over span of 6 months) to restaurant group owners
  - Clyde's
  - o Great American
  - o Bloomin Brands
  - o Darden
  - o Others
- The EDA has proposed a portion of ARPA funds be used on Consultant to advise on improvements to Hospitality Industry in Stafford (\$100,000). Some portions of this Action Plan will need additional staff or consulting resources.
- Request that developers secure FSR as part of proffers.
- Host meeting of brokers and developers for their insights on new restaurant development.
- Retail Roundtable. Local meeting(s) with retail and restaurant owners and developers to learn from their experience. Learn there current concerns and discuss opportunities to improve their business and more retail growth.
- Working with the FRA we will hold smaller scale "focus group" of FXBG restaurant developers
- Establish Tourism Zones across county. Offering some incentives in areas focused on appropriate development. These TZ incentives may include upfront cash grant, with claw backs, utilizing County Opportunity Fund. Tourism Zones to be presented to the Board under New Business in September or October. These Zones will coincide and compliment the *Stafford Area Place Development Plans*. Tourism Zones will be presented to the Board's Community Economic Development Committee tentatively in October or November.

As directed by the Board of Supervisors (BOS), the EDA met in a Special Meeting on March 29, 2022 to discuss and consider its recommendations for the uses of the \$2.9M in ARPA funds the Board has set aside for economic development purposes. These are our recommendations. The EDA met again on April 8 to discuss a draft of this Memo and how best to use ARPA funds for economic recovery. Finally, the EDA met on May 13 to finalize and approve this Memo and its recommendations in a unanimous 5-0 vote (two Members were absent but are in support of these programs and projects).

The EDA recognizes that the Department of Economic Development & Tourism may have capacity issues to implement deployment of these funds. This is not because of ability but because the Department is fully engaged in a wide range of other efforts. For this reason, the EDA recommends, overall, that the funds be used to fund "big projects or programs" and, to the extent possible, make use of other partners to distribute and administer, with appropriate reporting, the funds.<sup>1</sup> We recognize, too, there may be need for additional contracted staff.

The EDA discussed a variety of projects and ideas. Members admit that they do not have a comprehensive understanding of the ARPA Rules and rely on staff or County contractors to confirm eligible uses. Staff have taken extra hours to review the Rules and categorize these recommendations based on their understanding of the Rules.

Project and Program ideas can be categorized into the following key issues, identified by the EDA and Department and generally eligible and enumerated in the Rules.

- A. Workforce development for impacted individuals or employees in impacted businesses
- B. Training for impacted individuals, persons in impacted households and in impacted industries
- C. Direct support the Hospitality Industry, identified in the Rules as eligible industry
- D. Expenditures for neighborhood features to connect "disproportionally impacted communities."
- E. Entrepreneurial development for impacted households or impacted individuals
- F. Infrastructure, specifically water, stormwater, sewer, and broadband

Additional input was gathered by the Department's recent Tourism Advisory Group Meeting as well as input from specific partners (e.g., Germanna Community College, Stafford Schools, etc.). The balance of this Memo outlines the EDA recommendations categorized by the above key issue areas. Staff have identified sections and references to the Rules outlining the eligibility of the proposed uses and targeted populations.

#### Workforce Development (\$517,380)

The Rules clearly reference the changes in workforce and the labor market as a result of and exacerbated by the Pandemic. The EDA recommends the following to support for workforce opportunities for Impacted Households and Individuals

Eligible households and individuals include:

- household or population that experienced unemployment, experienced increased food or housing insecurity, or is low- or moderate-income experienced negative economic impacts resulting from the pandemic (page 37, 41), as defined
- Disproportionally impacted classes (pages 29-42)
- Individuals in Qualified Census Tracts (QCTs)

#### Projects:

- Direct marketing for new and advanced employment opportunities to individuals in Qualified Census Tracts, promoting new (advanced) positions in cyber and distribution businesses. In addition to marketing for these positions, the EDA proposes to use a limited amount of direct funds to encourage and support impacted households and individuals that are advancing within a business or who take a new position. The use of these funds for so called "wrap around" or direct costs are generally not available through workforce training agencies.
  - a. Contracted marketing effort for select number of Stafford businesses with over 50 new job openings. (\$72,000)
  - b. Partnered businesses (with at least 50 openings) will be provided funds to offer new or advancing employees direct "wrap around" costs not available through existing workforce development agencies, such as:
    - i. Travel and costs for persons taking new positions in County (recruitment for existing businesses). These would be available to candidates form QCTs
    - ii. Day care and other direct expenses for employees that were impacted by the Pandemic or are identified as eligible "class" in Rules
    - iii. Rental or other housing assistance for those that have stayed in work or take new positions and hold for 12 months
    - iv. Limited by available funds (maximum of \$3,000 per person; allocation of \$250,000, \$50,000 per business)
- 2. Purchase of advanced equipment, laptops, to support the Stafford Schools Cyber training initiative. Funds will purchase equipment to allow advanced teaching of cyber training, including virtual sessions for limited number of students in the program. (\$20,380)
- 3. Summer camps for children (aka day care). Funds directly to eligible organizations in Stafford that will document funds to eligible households (\$100,000)

#### Training (\$680,000)

The Rules document that "enumerated eligible uses [include] assistance to households or populations facing negative economic impacts due to COVID-19. Enumerated eligible uses include job training to address negative economic or public health impacts experienced due to a worker's occupation or level of training. (Page 80) The Rules document that training or other efforts to accelerate rehiring and thus reduce unemployment, such as childcare assistance, assistance with transportation to and from a jobsite or interview, and incentives for newly employed workers. (Page 116)

Finally, further guidance also provided that "public jobs programs, subsidized employment, combined education and on-the-job training programs, or job training to accelerate rehiring or address negative economic or public health impacts experienced due to a worker's occupation or level of training" are all enumerated eligible uses as assistance to unemployed or underemployed workers. (Page 116)

Eligible beneficiaries of assistance are defined as "individuals who want and are available for work, including those who have looked for work sometime in the past 12 months or who are employed part time but who want and are available for full-time work." (Page 116)

Also, recipients may provide job training or other enumerated types of assistance to individuals that are currently employed but are seeking to move to a job that provides better opportunities for economic advancement, such as higher wages or more opportunities for career advancement. (Page 118)

Eligibility under Rules

- household or population that experienced unemployment, experienced increased food or housing insecurity, or is low- or moderate-income experienced negative economic impacts resulting from the pandemic (page 37, 41), as defined
- Disproportionally impacted classes
- recipients may provide job training or other enumerated types of assistance to individuals that are currently employed but are seeking to move to a job that provides better opportunities for economic advancement, such as higher wages or more opportunities for career advancement (page 118)

#### Projects

- 1. Day Care Stipend for ARPA-eligible Germanna Community College students at its Stafford campus, with primary focus on health sciences and cyber students. (\$250,000)
- Support for new EMT and health services training program at Germanna Community College, specifically towards an emergency response training and operational vehicle (Page 61, "acquisition of emergency response equipment") used for training of new EMT and other health and first-responders. \$250,000
- 3. Funds to support Stafford teachers "post-covid" planning and training program at the schools strategic convocation, focused on what was learned and how to continue to engage with students impacted by the Pandemic. (\$180,000)

#### Hospitality Industry (\$655,000)

The Rules clearly identify the Hospitality Industry as an eligible Industry (Page 163). The Rules offer examples of eligible aid to include "aid for a planned expansion or upgrade of tourism, travel, and hospitality facilities delayed due to the pandemic." (Page 162-163). The EDA and Staff are familiar with some facilities (projects) delayed due to the pandemic and propose to support these, listed below.

#### <u>Projects</u>

- 1. Data marketing and deployment of additional kiosks—Phase II of Pilot Project (\$155,000) (*this was project proposed by the Department to the Board previously*). This was also recommended by the Tourism Advisory Group.
- 2. Development of and outdoor space (event venue) that was delayed by Pandemic. Direct matching grant of up to \$250,000
- 3. Funding (matching grant) for exhibit on the Langley Flight that will encourage hospitality visits and was delayed due to the Pandemic (\$150,000)
- 4. Consultant to advise on improvements to Hospitality Industry in Stafford. (\$100,000)

#### Connected Communities—Multiuse Paths (\$200,000)

The final rule includes enumerated eligible uses in "disproportionately impacted communities" that include developing neighborhood features that promote improved health and safety outcomes, such as parks, green spaces, recreational facilities, sidewalks, pedestrian safety features like crosswalks, projects that increase access to healthy foods, streetlights, neighborhood cleanup, and other projects to revitalize public spaces." (Page 132)

1. Staff recommends and EDA proposes to fund plans for connecting communities across the County. These funds would be contracted for planning and some pre-engineering and costing, but likely no capital expenses.

#### Entrepreneurial Development (\$300,000)

The Rules identify training and entrepreneurial development as "enumerated uses" in a number of places, including allowing for "assistance to unemployed workers seeking to start small businesses," (Page 116); and noting that "While businesses everywhere faced significant challenges during the pandemic, minority-owned and very small businesses have faced additional obstacles, and states that funds may be used for "technical assistance, counseling, or other services to assist with businesse planning needs. Treasury acknowledges a range of potential circumstances in which assisting small businesses could be responsive to the negative economic impacts of COVID-19, including for small businesses startups and microbusinesses and individuals seeking to start small or microbusinesses." (page 150).

The EDA recommends expansion and extension of entrepreneur programs, targeted impacted households, individuals, existing small business, and minority-owned persons or businesses seeking to expand.

Eligibility under the Rules

• individuals who have experienced a negative economic impact from the COVID-19 public health emergency, including uses that provide job training for unemployed individuals. These initiatives also may support small business start-ups, microbusinesses, and individuals seeking to start small or microbusinesses (page 151)

#### <u>Project</u>

 Funding to support RIoT Foundations and Accelerator Program, targeted to eligible individuals, households, and "classes." Including RIoT Foundations Program and in general supporting efforts from the Testbed and building entrepreneurial ecosystem. Portion of funds may be used to provide grant to businesses as part of "pitch" competitions; To help sustain programs 2023-2025.

#### Infrastructure (\$550,000)

The *Rules clearly enumerate the use of funds for water, storm water, waste water and broadband infrastructure*. The Board has supported some infrastructure projects in the County, focused on economic development (e.g., Tribal center, Austin Ridge). The EDA recommends additional projects that will support economic development.

The EDA recommends the following projects as part of the economic development allocation but respectfully recommends the Board consider funding these projects outside this allocation, thus allowing additional funds to be contributed to the other (non-infrastructure) above projects.

- Support water, stormwater, and sewer planning for new business center (location still confidential as this draft) (\$400,000)
- Support water needs for Patawomeck and proposed eco-center (\$150,000)

This LOCAL LEVEL INCENTIVES ECONOMIC DEVELOPMENT GRANT MEMORANDUM OF AGREEMENT ("Agreement") made and entered this \_\_\_\_\_ day of \_\_\_\_\_\_, 2022, by and among the BOARD OF SUPERVISORS OF STAFFORD, VIRGINIA, governing body of Stafford County, Virginia, a political subdivision of the Commonwealth of Virginia (the "County"), the ECONOMIC DEVELOPMENT AUTHORITY OF STAFFORD COUNTY, VIRGINIA, a political subdivision of the Commonwealth of Virginia (the "EDA"), and {INSERT APPROPRIATE MERRITT ENTITY NAME}, a corporation, authorized to transact business in the Commonwealth ("Merritt").

#### WITNESSETH:

WHEREAS, Merritt intends to develop five buildings, a total of 393,075 square feet, more or less, on Stafford County Tax Map Parcel No. 29-80C ("Facilities"), which will provide approximately 400 new jobs generated by tenants in the Facilities, expansion of business, and other benefits to the citizens of Stafford County; and

WHEREAS, the construction, equipping and operation of the Facilities will entail a capital expenditure by or on behalf of Merritt of approximately \$77,815,000; and

WHEREAS, the construction, equipping and operation of the Facilities will include Merritt's construction of a sewer line extension, which involves the installation of a new gravity sewer line to support the Facilities, other future commercial development, and provide a path for future improvements for residents along Cedar Lane, an estimated capital expenditure of \$2,150,000; and

WHEREAS, the development of the Facilities will also assist in the retention, expansion, and relocation of existing businesses and industries to the County; and

WHEREAS, in support of Merritt's development project, and to induce Merritt to make the capital investment in Stafford County, create new jobs, and assist in the retention, expansion, and relocation of existing businesses and industries in Stafford County, the County and EDA wish to offer a certain economic development incentive grant to Merritt in the amount of up to \$1,650,000; and

WHEREAS, the County is authorized by Virginia Code § 15.2-953, American Rescue Plan Act (ARPA) (Subtitle M of Title IX of Pub. L. 117-2; 87 Federal Register 4446), and other laws, and the EDA is authorized by the Industrial Development and Revenue Bond Act, contained in Chapter 49, Title 15.2 of the Code of Virginia and other laws, to provide ARPA funding and perform the activities contemplated in this Agreement; and

WHEREAS, the County and the EDA hereby find that the grant to Merritt meets a public purpose by diversifying Stafford County's tax base, creating jobs, assisting in the

retention, expansion, and relocation of existing businesses and industries to Stafford County, and enhancing the quality of life for the residents of Stafford County; and

WHEREAS, the County, the EDA, and Merritt desire to set forth their understanding and agreement as to the payout of the incentive grant, and the obligations of Merritt regarding the construction of the Facilities and extending sanitary sewer improvements along Cedar Lane.

**NOW, THEREFORE**, in consideration of the foregoing, the mutual benefits, promises, and undertakings of the parties to this Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

#### Section 1. Definitions.

For the purposes of this Agreement, the following terms shall have the following definitions:

"Capital Investment" means a capital expenditure by or on behalf of Merritt in taxable real property, taxable tangible personal property, or both, for the Facilities. The purchase or lease of machinery and tools or furniture, fixtures, infrastructure, and business personal property will qualify as Capital Investment. The Capital Investment must be in addition to the capital improvements at the Facilities as the date of this Agreement. An expenditure by or on behalf of Merritt in real property and/or tangible personal property at the Facilities which would be taxable in the absence of an applicable exemption will qualify as Capital Investment.

"Certificate of Occupancy" means any temporary or permanent document issued by the Stafford County Department of Development Services certifying that the building of one of the Facilities is in a condition suitable for occupancy.

"Economic Development Department" means the Stafford County Department of Economic Development and Tourism.

"Force Majeure" means any delay due to any moratorium on the issuance of governmental approvals, extreme unpredictable weather, fires, earthquakes, explosions, epidemics, pandemics, wars, riots, mob violence, area-wide strikes, union labor disputes or other union work stoppages, freight embargoes or inability to obtain basic materials or supplies by reason of shortages which generally affect the region in which the Facilities are located or which are national in scope, condemnation, acts of terrorism, acts of God, or, without limiting the foregoing, any cause not within the control of the party whose performance is interfered with, and which, by the exercise of reasonable diligence, the party cannot prevent.

"New Jobs" means new permanent full-time employment of an indefinite duration at the Facilities that are anticipated to be created by tenants in the Facilities.

"Performance Date" means on or before July 1, 2026. The Performance Date may <u>not</u> be extended.

"Virginia Code" means the Code of Virginia of 1950, as amended.

#### Section 2. <u>Performance Commitments</u>.

2.1 In return for the Local Level Incentive Grant set forth in Section 3 of this Agreement, Merritt shall construct the following on or before the Performance Date:

(a) Construction of Facilities. Merritt shall construct at least one building which shall be used to provide New Jobs generated by tenants, expand business, and other benefits to the citizens of Stafford County (the "Facility") and

(b) Cedar Lane Extension. Merritt shall construct sanitary sewer facilities along Cedar Lane, in accordance with the Stafford County Department of Utilities' standards and specifications (the "Cedar Lane Extension").

Construction of the Facility and Cedar Lane Extension, shall be collectively referred to as the "Project." Merritt shall build, construct, and execute the Project in accordance with all applicable building code standards; federal, state and local rules and regulations; the Stafford County Department of Utilities Water and Sewer Design and Construction Standards dated April 2017, as last revised; and the approved construction plans, attached hereto as Exhibit <u>A</u>. The Cedar Lane Extension shall be constructed to the standard satisfactory for acceptance into the County public sewer system.

#### Section 3. Local Level Incentive Grant.

3.1 To induce Merritt to make the Performance Commitments set forth in Section 2 above, the EDA agrees to provide Merritt with the following incentive grant ("Local Level Incentive Grant"), subject to appropriation of sufficient funds by the County, to be disbursed as provided in Section 3.1(a), below.

(a) Local Level Incentive Grant Disbursement. Local Level Incentive Grant funds will be disbursed to Merritt upon reaching completion of the Project on or before the Performance Deadline. Project completion shall consist of Merritt (1) obtaining a Certificate of Occupancy for at least one Facility; (2) acceptance of the Cedar Lane Extension into the County public sewer system; and (3) payment, by Merritt, of all connection and availability fees due to Stafford County. Within 30 days of receipt of certification of the Project's completion from the Stafford County Departments of Utilities and Development Services, the County will disperse Local Level Incentive Grant funds to the EDA, and within 30 days of receipt of the funds, the EDA will disburse the funds to Merritt.

**3.3** Payment of Taxes. In additional to the completion of Performance Commitments set forth in Section 2 above, the Local Level Incentive Grant funds will be paid to Merritt as set forth herein, so long as Merritt is current on all taxes and fees it owes Stafford County for any reason. If Merritt has been provided with written notice that it is in default on any payment or other provision of this Agreement, the EDA will not make any Local Level Incentive Grant disbursements to Merritt until

Merritt pays the amount it owes to Stafford County or otherwise cures the default to the satisfaction of the County and EDA. The Local Level Incentive Grant funds are subject to the Repayment obligations as described below in Section 6.

**3.4** Funds Subject to Board Appropriation. The County and EDA's Local Level Incentive Grant disbursement obligations provided under this Section 3 are solely conditioned upon the Stafford County Board of Supervisors providing the necessary funding as described herein and all other conditions being satisfied.

#### Section 4. Verification of Capital Investment and New Jobs.

(a) Verification of Capital Investment. Upon request, Merritt shall provide to the County and EDA real estate tax, business personal property tax, and machinery and tools tax information as requested to verify its Capital Investment in the Project. Such information shall be marked and considered confidential and proprietary and shall be used by the County Administrator and EDA solely for verifying Merritt's Capital Investment. If the County, EDA, Commissioner of the Revenue, or Treasurer should require additional documentation or consents from Merritt to access such information, Merritt shall promptly provide, at Merritt's expense, such additional documentation or consents as requested by the County, EDA, Commissioner of the Revenue, or Treasurer.

In addition to the verification data described above, in the sole but reasonable discretion of the County or the EDA, the County or the EDA may each require such other documentation, including invoices or audits as may be reasonably required to properly verify the Capital Investment.

#### Section 5. <u>Repayment Obligation</u>.

(a) Failure to Meet Performance Commitments. At a minimum, Merritt must meet the Performance Commitments set forth in Section 2 above. Should Merritt fail to meet the Performance Commitments by the Performance Deadline, the County and EDA may withhold disbursement of the Local Level Incentive Grant funds.

(b) Dispute Resolution. In the event of any dispute, controversy or claim of any kind or nature arising under or in connection with this Agreement (including disputes as to the creation, validity, or interpretation of this Agreement) (a "Dispute"), then upon the written request of any party, each of the parties will appoint a designated senior executive whose task it will be to meet for the purpose of endeavoring to resolve the Dispute. The designated executives will meet as often as the parties reasonably deem necessary in order to gather and furnish to the others all information with respect to the matter in issue which the parties believe to be appropriate and germane in connection with its resolution. Such executives will discuss the Dispute and will negotiate in good faith in an effort to resolve the Dispute without the necessity of any formal proceeding relating thereto. The specific format for such discussions will be left to the discretion of the executives but may include the preparation of agreed upon statements of fact or written statements of position furnished to the other parties. No formal proceedings for the resolution of the Dispute may be commenced until the earlier to occur of (a) a good faith mutual conclusion by the executives that amicable resolution through continued negotiation of the matter in issue does not appear likely or (b) the 90<sup>th</sup> day after the initial request to negotiate the Dispute. If the resolution of the Dispute requires any party to take, or cause to be taken or to cease taking, some action, such party shall be provided a reasonable period of time, not to exceed 90 days, to take, to cause, or to cease taking, such action.

#### Section 6. Term.

This Agreement is effective as of the date all parties have signed the Agreement and shall be in effect until December 31, 2026, if not sooner terminated as provided herein.

#### Section 7. Notices.

Formal notices and communications between the parties shall be given either by (i) personal service, (ii) delivery by a reputable document delivery service that provides a receipt showing date and time of delivery, (iii) mailing utilizing a certified or first class mail postage prepaid service of the United States Postal Service that provides a receipt showing date and time of delivery, or (iv) delivery by facsimile or electronic mail (email) with transmittal confirmation and confirmation of delivery, addressed as noted below. Notices and communications personally delivered or delivered by document delivery service shall be deemed effective upon receipt. Notices and communications mailed shall be deemed effective on the second business day following deposit in the United States mail. Notices and communications delivered by facsimile or email shall be deemed effective the next business day, not less than 24 hours, following the date of transmittal and confirmation of delivery to the intended recipient. Such written notices and communications shall be addressed to:

#### Section 8. Miscellaneous.

(a) Entire Agreement; Amendments. Approval of this Agreement by the County is provided pursuant to Resolution R22-\_\_\_\_, approved on \_\_\_\_\_, 2022. This Agreement constitutes the entire agreement among the parties hereto as to the Local Level Incentives Grant and may not be amended or modified, except in writing, approved by the Board and signed by each of the parties hereto. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns. Merritt may not assign its rights and obligations under this Agreement without the prior written consent of the County and the EDA.

(b) Governing Law; Venue. This Agreement is made, and is intended to be performed, in the Commonwealth of Virginia and shall be construed and enforced by the laws of the Commonwealth of Virginia. Jurisdiction and venue for any litigation arising out of or involving this Agreement shall lie in the Stafford County Circuit Court, and such litigation shall be brought only in such court.

(c) *Counterparts.* This Agreement may be executed in one or more counterparts, each of which shall be an original, and all of which together shall be one and the same instrument.

(d) Severability. If any provision of this Agreement is determined to be unenforceable, invalid or illegal, then the enforceability, validity and legality of the remaining provisions will not in any way be affected or impaired, and such provision will be deemed to be restated to reflect the original intentions of the parties as nearly as possible in accordance with applicable law.

(e) Attorney's Fees. Attorney's fees shall be paid by the party incurring such fees.

(f) Force Majeure. Notwithstanding anything to the contrary, neither party shall be liable or responsible to the other party, nor be deemed to have defaulted under or breached this Agreement, for any failure or delay in fulfilling or performing any term of this Agreement when and to the extent such failure or delay is caused by Force Majeure.

(g) *Mutual Assistance.* The County, the EDA and Merritt will do the things commercially reasonable, necessary or appropriate to carry out the terms and provisions of this Agreement, and to aid and assist each other in carrying out such terms and provisions.

#### FUND DISBURSEMENT AGREEMENT

This Fund Disbursement Agreement (this "Agreement") is made and entered into as of \_\_\_\_\_\_, 2022, by and between the Stafford County Economic Development Authority, a body politic of the Commonwealth of Virginia, ("EDA") and Exel Inc., a Virginia corporation, doing business as DHL Supply Chain ("DHL").

#### RECITALS

WHEREAS, on or about \_\_\_\_\_, 2022, the County and EDA did enter into that certain Transportation Partnership Opportunity Fund Grant Agreement ("TPOF Grant Agreement"), a copy of which is attached hereto, incorporated herein by this reference and marked as <u>Exhibit A</u>; and

WHEREAS, the TPOF Grant Agreement includes grant funds amounting to One Million Three Hundred Ninety-Two Thousand Dollars (\$1,392,000.00) (the "Grant Funds") to assist with certain roadway improvements located along Wyche Road in Stafford County, Virginia (the "Improvements"), for purposes of serving the new DHL Supply Chain Distribution Facility described more particularly in the TPOF Grant Agreement (the "Project"); and

WHEREAS, the TPOF Grant Agreement, among other requirements, authorizes the County to appropriate the Grant Funds to the EDA for purposes of funding the Improvements; and

WHEREAS, the Project is a significant economic development initiative within the County; and

WHEREAS, the EDA and DHL desire to set forth the terms and conditions upon which the EDA will disburse the funds to DHL to complete the Improvements.

#### AGREEMENT

NOW, THEREFORE, in consideration of the mutual benefits and covenants hereinafter set forth, the EDA and DHL hereby agree as follows:

1. <u>Recitals</u>. The foregoing recitals are hereby incorporated into this Agreement as a part hereof as if fully restated herein.

2. <u>Agreement</u>. In accordance with the terms herein, the EDA will provide DHL the Grant Funds upon DHL's completion of the Improvements. Once the Improvements are completed in accordance with approved construction plans, and accepted by the County and the Virginia Department of Transportation ("VDOT"), then DHL must provide the EDA with written notice and confirmation of the same, and request the release of the Grant Funds. Upon the EDA's review and receipt of said notice, the EDA, in accordance with the TPOF Grant Agreement, will disburse the Grant Funds to DHL within thirty (30) days thereafter.

4. <u>Governing Law.</u> This Agreement shall be governed by and construed under the laws of the Commonwealth of Virginia. Any jurisdiction's choice of law, conflicts of laws, rules, or provisions that would cause the application of any laws other than those of the Commonwealth of Virginia do not apply. Any and all disputes, claims. and causes of action arising out of or in any way connected with the Agreement or its performance must be brought in the applicable court of Stafford County.

5. <u>Notices</u>. All notices, approvals, consents, requests and other communications under this Agreement shall be in writing and shall be deemed to have been given when made in writing and either (a) delivered in person, (b) delivered by an agent, such as an overnight or similar delivery service, or (c) deposited in the United States mail, postage prepaid, certified or registered, addressed as follows:
